

Request access to the NXP's **SafeAssure NDA group** to get safety documents and received expert support for your functional safety applications.

if you **DO NOT HAVE** a valid NXP NDA in place

1. Request a **valid NXP NDA** (be active and have a broad scope covering functional safety documents) to your NXP contact.
You can reach one through our [Support hub](#).
2. Follow the next steps once you get a valid NDA for the **SafeAssure NDA group**.

if you **HAVE** a valid NXP NDA in place

1. Request access for the **SafeAssure NDA group** by reaching your NXP contact.
You might want to include a list of your company team members who need to check functional safety documentation and to be admitted —only corporate emails are accepted.
2. Your NXP representative will verify your NXP NDA and validate if is active and have a broad scope, covering functional safety documentations access. If required, a new NXP NDA will be initiated.
3. All your employees will receive a notification including the steps to follow for accessing NXP's **SafeAssure NDA group** once your application has been approved (up to 5 business days).
If additional employees require access thereafter, send their names and emails to SafeAssure@nxp.com.
4. Log in to community.nxp.com and go to your [community inbox](#) to accept the invite.
5. Review our [New to our community? guides](#). In case of need, you can submit any inquiry using the [ask a question](#) link.

NXP employees

1. Log-in to community.nxp.com using your NXP credentials.
2. Request access to the [SafeAssure NDA group](#)
Allow up to 3 business days for approval.

What is a valid NXP NDA for the SafeAssure NDA group?

A valid NXP NDA needs to **be active and have a broad scope** that covers safety documents to get SafeAssure NDA group access.
